The premises are located opposite the Sunniside Leisure Scheme and adjacent to Darke Cycles close to the junction of High Street West and John Street immediately opposite the Sunniside Leisure development where occupiers include Empire Cinema, Sunderland Bowl, Frankie & Benny's, Nando's and Grosvenor Casino Sunniside multistorey car park is also attached to the leisure scheme offering 653 spaces.

Description

The premises are located on the first and second floors and have the benefit of self-contained access from John Street.
