Location

South West Industrial Estate is an established industrial and commercial location benefiting from excellent communication links, located in close proximity to the A19 which is a 3-minute drive away.

Description

The property is a detached warehouse of steel portal frame construction with flat roof including glass skylights. The warehouse area has concrete flooring along with a minimum eaves height of 5.2m to the steel crossbeams raising to 6.4m at the roof sheeting. The roller shutter on the southern elevation measures 4.4m wide by 5.2m high with the roller shutter on the northern elevation measuring 3.8m wide by 5.2m high.

There is an office block located within the property which includes male and female WCs, a kitchenette area and broadly open plan office accommodation over ground and first floors.

The landlord intends to refurbish the property prior to a new tenant taking occupation and this will include LED lighting to both warehouse and office areas, full redecoration and installation of new roller shutter doors along with external redecoration of the cladding.
